FACTS	WHAT DOES HUNT INVESTMENT MANAGEMENT DO WITH YOUR PERSONAL INFORMATION?
Why?	<p>Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• name, address, phone number, age, and birthday</li> <li>• Social Security number and/or taxpayer identification number</li> <li>• assets and income</li> <li>• account balances</li> <li>• account transactions</li> <li>• transaction history</li> <li>• wire transfer instructions</li> <li>• checking account information</li> </ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	<p>All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Hunt Investment Management chooses to share; and whether you can limit this sharing.</p>

<b>What we do</b>	
<b>How does Hunt Investment Management protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Hunt Investment Management personnel are trained in the proper handling of nonpublic client information. Contracts with our service providers require them to (i) restrict access to your non-public personal information and (ii) to maintain physical, electronic and procedural safeguards against unintended disclosure.
<b>How does Hunt Investment Management collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>▪ open an account</li> <li>▪ provide account information</li> <li>▪ give us your contact information</li> <li>▪ make a wire transfer</li> <li>▪ tell us where to send the money</li> </ul> <p>We also collect your information from others, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
<b>Definitions</b>	
<b>Affiliates</b>	Companies related by common ownership or control, including but not limited to companies that provide administrative and business services, information technology, and other services in order to support us and our clients.
<b>Non-affiliates</b>	Companies not related by common ownership or control.
<b>Joint marketing</b>	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
<b>Other important information</b>	
<b>For Nevada residents only</b>	<p>We are providing you this notice under state law. You may be placed on our internal Do Not Call List by following the directions in the To Limit Our Sharing section. <b>Residents of California</b>	We will not share information we collect about you with nonaffiliates, unless the law allows. We will limit sharing among our companies to the extent required by law.
<b>Other Important Information For Vermont Investors</b>	We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
